Under Regulation 14 (a) (1) of APSEB Service Regulations Part-II as adopted by TSSPDCL, the Sub-Engineers/Elecl. featured in the Annexure are hereby appointed as Additional Assistant Engineers/Elecl. by transfer and posted to the places mentioned against their names, purely on temporary basis with effect from the date of actual joining duty in the time scale of pay of Rs.61640-2655-69605-3100-85105-3560-95785 with usual allowances admissible for Addl. Assistant Engineers (Elecl.) subject to the following given terms and conditions.

2. The appointments are subject to the following terms and conditions.
  - a. The appointment ordered above is purely temporary and do not confer any right for regular appointment as Additional Assistant Engineer.
  - b. The appointments are liable for termination at any time without notice and without assigning any reasons therefor.
  - c. It is subject to production of Physical Fitness Certificate issued by a Medical Officer of the rank not less than that of the Asst. Civil Surgeon at the time of joining as Addl. Assistant Engineer (Elecl.)
  - d. The candidates should produce Original Certificates of Diploma to the concerned Superintending Engineer for verification.
  - e. The candidates shall have to pass the prescribed tests as per the APSEB Service Regulations as adopted by TSSPDCL.
  - f. The appointment is subject to the genuineness of the certificates and recognition of the Course/Institute/University.
  - g. The candidates shall join duly within 15 days from the date of his/her relief.
  - h. The candidate is informed that if he does not report as Addl. Assistant Engineer within 15 days duly obtaining proper relief, the order of his appointment by transfer as Addl. Assistant Engineer shall be cancelled without further notice.
3. The above orders are also subject to the result of the following Writ Petitions/SLPs.

  - d. The WPs/SLPs filed on recognition of Degrees/Diplomas awarded by the Universities/ Institutions, if any.
4. These orders are also liable for review/cancellation depending upon the instructions/guidelines of the Government at later stage, if any.
5. The Seniority of the Additional Assistant Engineers/Electrical now appointed and the Additional Assistant Engineers/Electrical who may be appointed in the subsequent batches, if any, will be determined by the TSSPDCL separately.
6. If the individuals do not report for duty as AAE/Electrical within 15 days from the date of issue of these orders, their appointment orders stands cancelled automatically without further notice and their names will be excluded from the list of candidates appointed as AAEs/Elecl.




