#### **ORDER:**

Government have issued G.O's  $1^{st}$  and  $2^{nd}$  read above for the process to be followed for appointment of Directors on the Boards of various Organizations under Energy Department. The Directors shall be appointed initially for a term of (2) years and the tenure may be extended for a period of (1) year at a time upto a maximum of (2) extensions. Thus, tenure of the Directors shall be upto a maximum of (4) years only.

2. In the references  $3^{rd}$  to  $8^{th}$  read above, Government has appointed certain Directors in the Boards of TSSPDCL & TSNPDCL.
